There being no further business the meeting closed at 0930

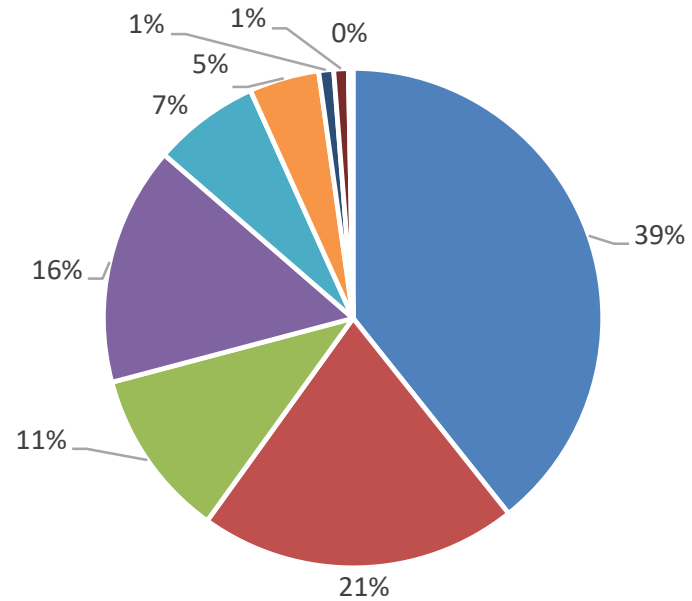
